ELECTION OF THE NEW MANAGING COMMITTEE: 2019-2021 OF THE CHITTARANJAN PARK KALI MANDIR SOCIETY (KMS) (ONLY FOR KMS MEMBERS)

With reference to the NOTICE dated 31.07.19, Order passed in the court of Shri Naresh Kumar Laka, Additional District Judge-03, South East, Saket Courts, New Delhi on 24th July 2019 in CS no. 450/19 and our Minutes of Meeting of KMS managing committee dated 02nd July 2019, it is to inform you that the managing committee has decided to nominate **Sh. P K Das (Mobile no. 9810722281)** in place of Sh. Suhan Basu as Election Officer for the forthcoming election of New Managing Committee of Chittaranjan Park Kali Mandir Society which is scheduled on 25th August 2019.

As per the order dated 01.08.2019, Ld. Court directed the MC to assemble on 01st or 02nd August 2019 to consider the aspect of change of the name of Election Officer namely Sh. 
The updated members list of Chittaranjan Park Kali Mandir Society has been published and is available at Secretary's office, KMS.
